Dear Neighbors:

Summer has been really great in Abell. We kicked off the season with a Memorial Day picnic, and have enjoyed our new Little Free Library at the Abell Open Space. The summer film series has been a huge success once again. It was also a time of transition in the community. Drew Walker, who served as AIA president for a year and a half, was offered a teaching position in Washington State. Drew stepped down as president to take advantage of this great opportunity. It was sad to say goodbye to Drew and his partner, Kevin Darrow, who served as our treasurer. But we wish them the best in their new adventures and thank both of them for many years of service to the Abell community. As vice president, I agreed to serve out Drew's term as president. Andy Scott has agreed to serve as treasurer for the remainder of the term. And Linda Forlifer has agreed to add the corresponding secretary role (which Andy Scott held) to her existing role of recording secretary. Thank you to everyone who has been so flexible and willing to pitch in during this time of transition!

The annual Abell Community Street Fair, our biggest event of the year, is coming up in just a few weeks. This year the fair is on **Sunday, September 22, from noon to 5 p.m. in the 3100 and 3000 blocks of Abell Avenue.** This year's fair includes everything you've come to expect: the All-U-Can-Eat Crab Feast (buy advance tickets on p. 4), Baltimore's Best Silent Auction, fabulous local artists and vendors, live music from Jazz Lunch, Chris Pumphrey, The Timothy Bracken Complex, and The Happy Hours. Many thanks to Abell resident Jon Birkholz for arranging this year's music line-up. We will also have great kids' activities, including the Children's Parade (Harry Potter themed this year!).

The Street Fair is also the **AIA's biggest fundraiser.** We use the proceeds from the Fair to pay for the programs, events, and activities that make our community stronger. Over the past year, these have included funding a **Mini-Grants Program** for teachers at the Barclay School, paying the licensing fees that allow us to show movies during our **Summer Film Series**, as well as hosting a variety of get-togethers, picnics, and other social events. By supporting the Street Fair, you make these things possible.

Please consider volunteering at the Street Fair. Inside on page 3, you'll find out where and when we need help on the day of the Fair. Please call or email me if you are interested in volunteering. #### \* \* \* PARKING REMINDER \* \* \*

In preparation for the Street Fair, all residents are required to move vehicles from the 3000 & 3100 blocks of Abell Avenue and the 300-400 blocks of 32<sup>nd</sup> Street between 8 a.m. and 6 p.m. on Sunday, September 22. Free parking is available on the northeast corner of Barclay and 32<sup>nd</sup> Street.

#### Barclay **Elementary/Middle School**

Early in July North Avenue administrators transferred Principal Jenny Heinbaugh out of Barclay School and appointed a Principal Selection Committee (PSC) to interview candidates for her replacement. The committee consisted primarily of teachers plus 2 parents, 2 individuals from the school's community engagement team, and the chair of that team, Kelly Oglesbee. One of the engagement team representatives was Abell resident Jo Ann Robinson. Because the Baltimore City schools' hiring cycle begins in January, very few candidates were left to be interviewed in July. The PSC determined that the post of Barclay Principal is too important to be filled by a hurried, last-minute process from a shallow pool of candidates. Consequently, we did not choose a principal. Instead, system administrators have appointed a Managing Assistant Principal (MAP) for the new school year. In January the principal selection process will be activated again. Ms. Bettye Adams will serve as the Barclay MAP. She comes from Locherman **Bundy Elementary School** where she was Assistant Principal last year. We look forward to getting to know her and continuing AIA's long tradition of support for Barclay School.

Art was huge hit this summer - we served over 40 kids and their families with visual arts programs and 20 students with dance camp. And summer isn't summer without physical activity! With our basketball skill development camp and our open gym program, we served over 100 kids and adults.

#### **Brewery News**

Peabody Heights Brewery at 30<sup>th</sup> and Barclay has applied for a new Class D liquor license that would allow an expansion of hours and retail sales onsite and off-premises. With this new license, the brewery could serve pints at the bar and fill growlers. The license would also allow the brewery to expand the number of events they can have a year. With their current license and zoning, they can hold 12 events a vear. The new license would allow an unlimited number of events. However, the owners are proposing they voluntarily limit the events to 36 per year.


Although the license allows for licensees to be open 6 a.m. to 1 a.m. Monday through Saturday, the brewery owners are proposing voluntary restrictions on the hours. For retail hours in the tasting room, they propose the following hours:

Monday - Thursday, 4-7 p.m. Friday, 4-8 p.m. Saturday, 11 a.m. -8 p.m.

At the AIA general membership meeting on August 24, the membership voted to engage the services of the nonprofit Community Law Center to help AIA develop a memorandum of understanding (MOU) with the brewery owners. Ideally, the MOU would help set limits on the brewery's license that would insure the new activities do

not have a negative impact on the community.

## **Baltimore City Animal Control Laws**

Fresh Water Make sure your pets have access to fresh water at all times when kept outdoors.

Avoid Rats Pet food and animal waste attracts rats. Clean up after your pets often and don't leave food out overnight.

Shelter The law requires pet owners to provide shelter (e.g., a dog house) for dogs kept outdoors. The shelter must be elevated 2 inches off the ground with a flap on the door to help reduce drafts. Whenever the temperature falls to 40° F or lower, all domestic animals should be brought indoors.

Animal Waste must be picked up immediately. It is a violation to leave animal waste on your property, and while walking your animal on public property, parks, and private property, without promptly removing it.

Exercise for your dog Dogs should be walked twice a day. Baltimore City requires that dogs be leashed at all times. Violators can receive a \$100 citation. The city operates two dog parks for unleashed play. Call 311 for locations.

#### PLEASE NOTE: YOU MUST BRING A PHOTO ID!

Register online after September 20 for RPP Area 12 Charles Village & Abell 12A Permits.

After October 19, you MUST go downtown to the city's Parking Authority office to pick up your permit.

Residents of Charles Village in the Residential Permit Parking (RPP) Area 12 (north of 29<sup>th</sup> Street, west of Hunter Street/alley) and 12A-Abell (north of 29<sup>th</sup> Street, east of Hunter Street/alley) must register and purchase their annual parking permits and visitors passes.

**All current permits expire October 31.** You must show proof of residency to ensure that participation in the program is limited to *residents only*. To be eligible for a Parking Permit and/or Visitors Pass, you must reside within the boundaries of the RPP area. Warning — a parking citation (fine) for not displaying a current RPP decal or visitor's pass in Area 12/12A is \$52 for each occurrence.

If you do not have internet access, you may go to the Village Learning Place, 2521 St. Paul Street, to use a computer in the library for applying online.

**Baltimore City's annual Residential Parking Permits cost:** 

\$20 for a Parking Permit (decal)

\$20 for a Visitors Pass

If you currently have a parking permit, you are already in the City's RPP database and you do not have to re-enter your information. Use the same user name and password that you used last year. If you have forgotten your user name and/or password, call the Parking Authority at 443.573.2800 and staff will help you reset your password.

If this is the FIRST TIME you are applying for a parking permit, you MUST go downtown to the Parking Authority office at 200 W. Lombard Street, Suite B, to apply for and pick up your parking permit in person. The Parking Authority will provide you with validation to park for free in the garage above their office.

NOTE - The information above *only* applies to Residential Parking Permits and Visitors Passes in AREAS 12 and 12A (Charles Village and Abell). Charles Village WEST (Area 37) renewal and pick-up takes place in March, 2014. Area 37 is defined as west of Charles Street between 26<sup>th</sup> Street and 29<sup>th</sup> Street, including the unit block of E. 26<sup>th</sup> Street.
